Office Setup:

Staff Recruitment

Reception of 100 million naira kick off Fund

The Kwara State Education Trust Fund received the 100 million naira kick off Fund promised by your excellency, this has enabled us commence the payment of sitting allowances to board members and salaries to the staff of the trust fund.

Official Launch and Fundraiser Program Planning:

Initiated plans for the official launch of the Kwara State Education Trust Fund, outlining the event goals and objectives, structure, agenda, and guest list.

Commenced preparations for a fundraising activity to support Kwara State Education Trust Fund Educational initiatives, including sponsorship outreach, and program development.

Partnership Building:

Formed strategic partnerships with the Ministry of Education and Human Capital Development and other relevant government agencies and programs to collaborate on educational projects and programs.

Engaged in discussions with potential partners from the private sector, civil society organizations, and international agencies to explore opportunities for collaboration and resource mobilization.

Board Growth:

Successfully populated the Kwara State Education Trust Fund Board with representatives from key stakeholders, including the Ministry of Justice, Parent-Teacher Association (PTA), and Teaching Service Commission (TESCOM). Conducted orientation sessions for newly appointed board members to familiarize them with Kwara State Education Trust Fund's mandate, objectives, and governance structure.

In the coming months, we will focus on executing the plans for the official launch of Kwara State Education Trust Fund and the fundraising event, as well as strengthening partnerships with stakeholders to maximize our impact in the education sector.
